1. INTRODUCTION TO THE NRF

The National Research Foundation ("NRF") is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government's national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS Cape Town.

2. INTRODUCTION TO THE NRF BUSINESS UNIT RESPONSIBLE FOR THIS BID

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and applied nuclear physics research using particle beams
- Research radiation biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

iThemba LABS Cape Town seeks to appoint a reputable Supplier to supply and deliver fresh produce to the kitchen at iThemba LABS Cape Town as required by National Treasury Regulations (NTRs) and Public Financial Management Act (PFMA) through an open and competitive process so that it can realise the benefits of the strategic sourcing which includes, amongst others:

- Reducing the cost of effort and administration
- Minimising price inconsistencies
- Reducing inadequate contract management and service delivery

The parties will agree, provided an agreement can be reached to the mutual satisfaction of each in regard to matters such as the specifications of the works, the price to be paid therefore, the performance required and the delivery date.

SECTION 1: Process Description & Administrative Requirements.

1 Intent of the document

This Request for Proposal is intended to allow the successful Supplier to specify and present their skills, expertise and price for the above mentioned services to iThemba LABS Cape Town. Final acceptance of any proposal is not guaranteed this being the exclusive right of iThemba LABS. The purpose of this RFP is to invite proposals for the **Supply and Delivery of Fresh Produce (Fruit and Vegetables) on an as required basis for a period of two (2) years** with the right to cancellation due to non – performance.

2 Background

iThemba LABS has a dedicated kitchen that caters for meals, snacks and the catering requirements of onsite meetings and several conferences. It is operational 40 hours a week from Monday to Friday. The kitchen staff are dedicated to providing a value-added, world-class service to all its stakeholders.

3 Mandatory Returnable Administrative and Evaluation Document Requirements

Pricing must be filled in on this document and can be supported by a separate proposal.

Detailed proposal and any additional information must accompany this signed Request for Proposal (RFP).

Prices supplied should be fully inclusive of all costs; value added tax, delivery charges and other taxes.

Prices must be in South African currency.

Price summary supplied in this document is firm prices.

Proposals not complying with the Technical Specifications will not be considered.

Bidders not submitting mandatory returnable administrative and evaluation documents (Table 1.1) will not be considered for evaluation.

4.1.3 Please note that this RFP closes punctually at 11:00 am on 04 August 2017. No late bids will be accepted.

4.1.4 If responses are not delivered as stipulated herein, such responses will not be considered and will be treated as “UNRESPONSIVE.” This included bids that are delivered late.

4.1.5 No email or facsimile responses will be considered, unless otherwise stated herein.

- 4.1.6 The responses to this RFP will be opened as soon as practicable after the expiry of the time advertised for receiving them.
- 4.1.7 iThemba LABS shall not, at the opening of responses, disclose to any other company any confidential details pertaining to the Proposals / information received i.e. pricing, delivery, etc. The names and locations of the Respondents will be divulged to other respondents upon request.
- 4.1.8 Envelopes must not contain documents relating to any RFP other than that shown on the envelope. All envelopes must reflect the return address of the Respondent on the reverse side.

5 Awarding of Request for Proposal and Appointment of Contractor.

- 5.1 Awarding of contractor will be published on iThemba LABS tender website. Regret letters will be sent out to unsuccessful bidders.
- 5.2 iThemba LABS will award the contract to qualified bidder(s)' whose proposal is determined to be the most advantageous to iThemba LABS, taking into consideration the technical (functional) solution, price and B-BBEE.
- 5.3 Appointment as a successful contractor shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions. In the event of the parties failing to reach such agreement iThemba LABS reserves the right to appoint an alternative supplier.

6 Evaluation Process.

- 6.1 Preference points system:
- The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bids received are more than R500 000, the proposal will be cancelled and re-issued.
- 6.2 Pricing Proposal:
- 6.2.1 Price needs to be provided in South African Rand (incl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 6.2.2 Only firm prices* will be accepted during the bid validity period. Non-firm prices** (including prices subject to rates of exchange variations) will not be considered.
- 6.3 Validity Period of the Proposal:

Each proposal shall be valid for a minimum period of three (3) months calculated from the closing date.

7 Communication.

- 7.1 Bidders are warned that a Proposal will be liable to disqualification should any attempt be made by a Respondent either directly or indirectly to canvass any officer or employee of iThemba LABS in respect of this RFP between the closing date and the date of the award of the business.
- 7.2 For specific queries relating to this RFP, Respondents must contact SCM Office in writing. In the interest of fairness and transparency iThemba LABS response to such a query will then be made available to the other Respondents who have attended the compulsory site clarification meeting.
- 7.3 After the closing date of the RFP, a Respondent may communicate with iThemba LABS Supply Chain Management Section, at scm@tlabs.ac.za on any matter relating to its RFP proposal.
- 7.4 Respondents found to be in collusion with one another will be automatically disqualified and blacklisted from doing business with iThemba LABS in future.

SECTION 2: GENERAL SPECIFICATION

The successful Supplier is expected to supply and deliver fresh produce such as fresh and pre-cut fruits and vegetables on an “as requested” basis for the on-site kitchen, subject to an agreement being reached on the quality specifications and weekly pricing schedule of the goods listed, with the right to cancellation due to non – performance.

The intent is to allow the supplier to specify and present their skills, expertise and pricing for the listed products to iThemba LABS. Final acceptance of any proposal is not guaranteed this being the exclusive right of iThemba LABS.

DESCRIPTION OF WORKS

2.1 SCOPE OF WORKS

- 2.1.1 Supply and delivery of fresh and pre-cut fruit and vegetables on an as and when required basis for a period of two (2) years.
- 2.1.2 All products must be fairly clean and suitable for human consumption.
- 2.1.3 All products (fruit and vegetable) should be free from:
 - Any damage from insects or disease
 - Decomposition or decay
 - Blemishes and unattractive appearance
 - Bruises from sun or heat damages
 - Soil and/or sprouts
- 2.1.4 The Supplier shall be required to deliver a predetermined quality and quantity of the fresh produce as stipulated by an iThemba LABS official order.
- 2.1.5 Suppliers must adhere to delivery schedule and iThemba LABS conditions.
- 2.1.6 All goods/ products must be produced according to and fully comply with the South African Legislations (Acts and Laws) and Standards.

2.2 COMPLIANCE WITH LAWS

- 2.2.1 The successful bidder must, in performance of work under this contract, fully comply with all applicable legislation (Acts and their regulations) and South African National Standards. These include, but are not limited to:
 - **Health Act, 1977 (Act 63 of 1977)/ National Health Act 2003 (Act 61 of 2003):** No person must handle food or permit food to be handled on food premises in respect of which a **valid certificate of acceptability** has not been issued or is not in force (**Regulation 918 of the Health Act (Act 63 of 1977)** by the local authority.

- **Agricultural Product Standards Act, 1990 (Act No. 119 of 1990):** To provide for the control over the sale and export of certain agricultural products, control over the sale of certain imported agricultural products, control over related products and for matters connected with.
 - **Government Notice No. R364 of 24 May 2013:** Regulations relating to the grading, packing and marking of fresh vegetables intended for sale in the Republic of South Africa.
 - **Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972):** To control sale, manufacture and importation of foodstuffs, cosmetics and disinfectants and to provide for incidental matters.
 - **Government Notice No. R198 of 30 July 1999:** Regulation governing general hygiene requirements for food premises and the transport of food.
 - **SANS 10049:2012 (SABS049):** Food safety management – Requirements for prerequisite programmes (PRPs).

2.3 SPECIFICATION OF GOODS

- 2.3.1 Quality specifications of the goods will be class 1 as defined by legislation defined in relevant legislations and standards.
- 2.3.2 Estimated average weekly fruit and vegetable usage:
- Pre-cut vegetables: 60 kg/ week
 - Other whole vegetables: 100 kg/ week
 - Whole fruits: 50 kg/ week
- 2.3.3 iThemba LABS recognizes that all of the items listed in pricing schedule will not be available at all times during the year due to seasonal availability and would not expect the successful Supplier to have every seasonal item in stock year round.
- 2.3.4 iThemba LABS reserves the right to buy seasonal fresh produce.
- 2.3.5 If you have items in your purchase catalogue, which are not listed individually on the RFP, include these items to indicate the variety you have available.

2.4 CERTIFICATION OF QUALITY

- 2.4.1 All produce delivered must be securely boxed, wrapped or bagged and hauled in covered trucks. No other items will be transported in the same vehicle which might in any way contaminate or damage the produce.
- 2.4.2 All produce delivered will be **inspected at the time of delivery**. Invoices of accepted items will be signed. Discrepancies will immediately be called to the attention of the supplier, so that corrective action may be taken. The Supplier will be responsible for produce rejected at the point of delivery and produce found to be defective within the use by date for the product. Damaged or inferior produce for which the supplier is responsible will be replaced at no additional cost to iThemba LABS or a credit note will be issued for goods returned for credit.
- 2.4.3 Reasons for product rejection may be one of the following:
 - 2.4.3.1 Inferior quality
 - 2.4.3.2 Prices not as per line item on invoice compared with official purchase order (NPO).
 - 2.4.3.3 Damaged products
 - 2.4.3.4 Product does not meet RFP specifications

2.5 ORDERING

- 2.5.1 The successful bidder will be issued an **official purchase order** (NPO) from iThemba LABS starting with “**NPO-**” as confirmation of the award and their notice to proceed with supply and delivery.
- 2.5.2 **Ongoing official orders will be raised on an “as required” basis** via email two (2) to five (5) days prior to the required delivery date by the kitchen supervisor or a supply chain official for the duration of the agreement.
- 2.5.3 **The quantities listed** herein are estimates only and are not intended to commit iThemba LABS to purchase any specific quantity. In the event that iThemba LABS’s requirements do not result in the request for the full amount described herein, such occurrences shall not constitute the basis for fee adjustments under this contract.
- 2.5.4 If the successful supplier is unable to supply the fresh produce required on the NPO, he/she shall recommend an acceptable replacement product to the kitchen supervisor for approval.

2.5.5 If the bidder requires a minimum order quantity, it must be stated on their proposal.

2.6 DELIVERY OF GOODS

2.6.2 **Delivery schedules:** Delivery will be required 2 - 3 times per week, preferably on a Monday, Wednesday and Friday between 7:00 and 15:30 or as mutually agreed between iThemba LABS and the successful bidder.

2.6.3 Delivery schedules will be altered to meet holiday schedules. If the holiday falls on a scheduled delivery day, the delivery shall be made on a day to be mutually agreed upon by iThemba LABS and the successful bidder.

2.6.4 The products must be transported under hygienically acceptable conditions i.e. closed vehicles.

2.6.5 Delivery vehicles are to be equipped so that the proper state of refrigeration is maintained for any perishable product as per applicable legislations, standards and regulations. Temperatures shall be no lower than one degree Celsius and no higher than 14 degrees Celsius at during transport and at the time of delivery. Boxes and cartons must not exhibit signs of condensation or dampness but must be dry and in good condition.

2.6.6 Delivery to be made according to agreed specifications, agreed costing and quantities indicated on the official order (NPO).

2.6.7 All fresh produce must be delivered inside the kitchen at the receiving area.

2.6.8 The kitchen supervisor or designee will check items delivered against the official purchase order and invoice at the time of delivery with both the supervisor of designee and the driver signing the appropriate documentation for shortages and errors, and/or obviously damaged / non-compliant goods.

2.6.9 iThemba LABS reserves the right to reject any product that does not conform to the specifications and quantity of invoiced product when received. Rejected items to be removed immediately and credit memo issued.

2.6.10 Delivered fresh produce will be **invoiced** according to agreed costing.

- 2.6.11 **Original tax invoices** indicating NPO, fresh produce items supplied, units of measure, quantity supplied, price per unit and total cost inclusive of vat must be supplied per NPO for each delivery.
- 2.6.12 If deliveries are made in boxes, cases, crates or on racks, proper sanitation of these items is the responsibility of successful bidder.
- 2.6.13 The successful bidder shall bear the full burden of ownership until the produce is accepted at the final destination. Any shortages, damages, losses or otherwise undelivered produce shall remain the successful bidder's responsibility.

3. PRICING SCHEDULE

- 3.1 The pricing of fresh produce offered by supplier must be market related. iThemba LABS reserves the right to check the pricing of the supplier whether or not it is market related.
- 3.2 Due to the price fluctuation of the fresh produce, the supplier shall provide a weekly pricelist to the kitchen supervisor.
- 3.3 The weekly pricelists for fresh produce must be provided to the kitchen supervisor via email for the purpose of creating an official request for order (RFO) with iThemba LABS supply chain.

4.1. The contracted supplier ensures all work performed and/or equipment used on site complies with the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations).

4.2. To this end, the contracted supplier shall make available to NRF the valid letter of good conduct and shall ensure that its validity does not expire while executing this bid.

GENERAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, and words such as “will/should” mean “must”.

The NRF cannot amend the National Treasury’s General Conditions of Contract (GCC). The NRF appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause directly below the specific GCC clause and where the NRF requires a SCC that is not part of the GCC, the NRF appends the SCC clause after all the GCC clauses. No clause in this document shall be in conflict with another clause.

1. Definitions - The following terms shall be interpreted as indicated:

1.1. “Closing time” means the date and hour specified in the bidding documents for the receipt of bids.

Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. "Day" means calendar day.
- 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10. "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars, or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.

- 1.14. "GCC" means the General Conditions of Contract.
- 1.15. "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16.
