The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bidders received are more than R500k, the proposal will be cancelled and re-issued.

Procurement , installation and commissioning of six Level Sensors –
The sensors are separate level measurement units/ systems using differential pressure transmitters

USAGE

The level sensors are used at the water level measuring system for our Pressure Vessels

The sensors are separate level measurement units/ systems using differential pressure transmitters

Location of installation: Heat exchanger circuit pressure vessels

Vessel Type: Stainless steel pressure vessel (50Kpa with Nitrogen)

Vessel Capacity: 4 of 400l and 2 of 300l capacity

Requirement: Six separate installations using specific differential pressure transmitters

SCOPE OF JOB:

The Supply, fitting and commissioning of differential pressure transmitters at each of six pressure vessels (see parts list below with make and model recommendation).

Each Transmitter to be fitted onto a 2" stainless steel post with base plate for mounting of P310, the base plate to be floor standing next to the vessel. The transmitters are attached to a set of capillary tubes to diaphragm seals located top and bottom of the pressure vessel where the Diaphragm seal is terminated to existing ½" bsp threaded S/S 316 Navy unions. Transmitter is mounted to be clearly visible in terms of its displayed parameters. The Transmitter is to be calibrated in percentage of fill.

The commissioning is to be completed by the installer to the point where the units are local display and 4-20mA output calibrated. (iThemba Labs will supply all cabling required for remote connection e.g. 2 wire 4-20mA as well as power supply 24V DC at each transmitter point). The installation is to be carried out on a running plant where extreme care must be exercised not to interfere with normal plant function. iThemba LAB will connect to its own process system using the transmitted signals.

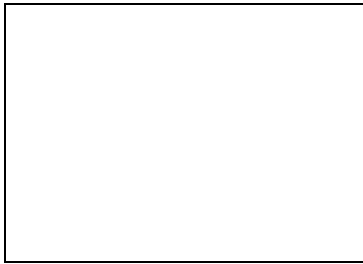
